Fee Structure for the Year 2026

Eco- Tourism Committee Ghulkin

Ghulkin Local Agency for Development (GLAD) is a registered organization and Eco-Tourism Committee Ghulkin is one of its Portfolio. The committee has decided the following fees structure for all the touristic spot of Ghulkin village. Effective from 1st March 2026.

1. Porters Fees Details:

- Per stage per porter fee is Rs.2220/-
- Food chargers per porter Rs.1500/-
- Equipment Charges per porter Rs.1200/-
- One day rest charges below 4000m per porter Rs.800/- and above 4000m per porter Rs.1600/-

2. Camp Fees Details:

- Member tent Fee Rs.400/- per day.
 - Kitchen Tent Fee Rs.500/- per day.
 - Mass Tent Fee Rs.600/- per day.
- Porter Sardar fee Rs.1800/- per stage for 01 to 10 porters and for 11 to 20 porters 02 porter sardar fee will be charged.
 - Tracking fees Rs.600/- per person up to Patundass Meadow.
 - Stages of stay for group up to Patundass Meadow are 06 and up to Yorch are 08.

Patundas & Surrounding Meadows – Regulations & Guidelines

1. Mandatory Guide Requirement

It is strictly prohibited for any tourist (domestic or foreign) to trek or tour in Patundas or other meadows without a certified guide.

2. Cooking Arrangements for Porters

The company is responsible for providing kerosene oil and a gas stove to porters for cooking in both summer and winter seasons.

3. Porter Load Limits

- Maximum 20 kg per porter (Summer)
- Maximum 15 kg per porter (Winter)

4. Insurance Coverage

All tour operators must ensure proper insurance coverage for porters.

5. Waste Management

All garbage must be carried back by the group or tour operator to Shahabad Zero Point or their hotel.

Any violation will result in a heavy fine imposed by Gulkin Eco Tourism representatives.

6. Guide Availability

If a company guide is unavailable, Gulkin Eco Tourism or the local community will arrange a guide for individuals or groups.

7. Conservation & Legal Compliance

Patundas Meadows and the surrounding Borith area are protected community-based conservation zones.

- Hunting and destruction of wildlife (animals or plants) are strictly prohibited.
- Any violation will result in legal action under the laws of the Government of Pakistan and local conservation authorities.

Important Notes

- **Patundas Round Trek is currently closed.**
- When operational, porters will charge for 6 stages from Borith (Shahabad Zero Point) to (Sarseen).
- In case of a bonfire, the group is responsible for carrying firewood from Borith to Patundas.
